TUITION POLICY

Application Fee: is due at time of registration and is non-refundable and non-transferable. No exceptions will be made. This is an annual charge for each prospective student for the application processing.

June Tuition/Security Deposit: is no longer necessary at the time of registration :) This payment is due June 1st.

September Tuition: is due on or before Sept.1st.

Refunds: There will be no refunds or make up days for absences, school closings, early withdrawals or inclement weather.

Registration: CFA will do all we can to accommodate requests for specific teachers and aides. However, teacher and aide selection is not guaranteed.

Payments: All payments are based on a yearly commitment. Payments must be paid in monthly installments (September 1st – June 1st). All tuition payments are due no later than the 5th of the month. All late payments will incur a \$15.00 late fee to be paid at time of tuition payment. **No Exceptions.** A fee of \$20.00 will be charged for any returned checks.

If your child drops out before November 1 and their space is filled with another child, CFA will waive the balance of payments. If space is not filled or child drops out after November 1 all monthly payments for the full year are still due.
